#### Looked After Children: Definitions and Status

- The term “**looked after**” generally refers to a child under the care of the Local Authority. This includes children subject to a care order or those temporarily looked after on a planned basis, such as for short breaks or respite care.

- Most looked after children are cared for by foster carers, with a smaller number living in children's homes, with family members, or placed back within their birth family.
  - **Important:** "Looked after" denotes legal status. The nursery does **not** use this term to single out a child or use acronyms such as "LAC."

### Our Approach

- We embrace the core principles of the EYFS: every child is unique and learns best in a secure, positive relationship with their carers.
  - We assess how settled a child is with their primary carer to support successful transitions into the nursery environment.
  - Our staff understand that children enter care for various reasons and are committed to supporting each child to reach their full potential.
  - We maintain an open-door policy for staff to discuss concerns or sensitive issues regarding any child. All staff are familiar with our **Child Protection Policy**.
  - Where required, we contribute to multi-agency assessments or meetings. The designated person for looked after children, or the child's key person, will attend as appropriate.

### Support for Looked After Children at Bizzie Lizzie

- Each child is assigned a **key person** to support settling, transitions, and ongoing relationship-building with the child and their carer.
  - The key person completes a **Settling-in Plan** with the child's main carer before the child begins nursery.
  - Regular observations are carried out by the key person to monitor progress and share information with carers and relevant professionals.
  - For children over three, a **Personal Education Plan (PEP)** is completed to track progress, identify gaps, and plan interventions.
  - The key person and the designated safeguarding lead collaborate to ensure smooth transitions to school or alternative settings.

### Who is Considered a 'Looked After' Child

- A child accommodated by the Local Authority with parental agreement (Section 20 of the Children Act); parental responsibility remains with the parent.
  - A child subject to a Care or Protection Order.
  - A child accommodated for planned short breaks (e.g., children with severe disabilities or whose parents have significant needs).
  - A child remanded to Local Authority care (typically aged 10 or over).

### **Who is Not Considered a 'Looked After' Child**

- Children living at home with their parents.
- Children in private fostering arrangements (non-family).
- Children living with family members (e.g., aunt, grandparent) under informal arrangements.
- Children subject to **residence orders** or **special guardianship orders**.
- Adopted children (after adoption is finalized; prior to this, they are considered looked after).
- Care leavers.
