## Aims

- To promote positive attitudes towards diversity, challenging discrimination and bias.

- To provide tailored support to ensure all children can access and benefit from learning and care.
- To work in partnership with parents, carers, and the wider community to promote inclusion.

## **Commitment to Equality and Inclusion**

### **Race, Culture and Religion**

- We actively promote respect and understanding of all races, cultures and religions.
- Resources, books and activities reflect a range of cultural backgrounds.
- Children are encouraged to share and celebrate their own traditions and beliefs.
- Staff challenge stereotypes, racist behaviour or language immediately and appropriately.

### **Special Educational Needs and Disabilities (SEND)**

- We are committed to early identification and support for children with SEND.
- Individual plans and reasonable adjustments are made to meet children's needs.
- We work closely with parents and external agencies to ensure inclusive practice.
- Staff receive training to support children with a range of needs and abilities.

### **Socio-Economic and Financial Inclusion**

- No child is excluded because of their family's financial circumstances.
- We provide clear information on fees, funding, and support with government schemes.
- Families facing hardship are treated with dignity and offered guidance to access available support.

### **Gender and Family Diversity**

- We provide a non-stereotypical learning environment where children can explore freely.
- We respect and include children from all family structures, including single-parent families, same-sex parents, foster and kinship carers.

- Staff model inclusive language that recognises family diversity.

## **Staff Practice**

- Staff model inclusive attitudes and respect in all interactions.
- Training is provided on equality, diversity, inclusion, and unconscious bias.
- Recruitment and employment practices promote equality of opportunity.
- Staff work in partnership with parents, valuing their role as the child's first educator.

## **Challenging Discrimination**

- Any incidents of discriminatory behaviour, language, or exclusion are taken seriously.
- Staff will record incidents, inform parents, and take appropriate action.
- Repeated or serious incidents will be reported to the Designated Safeguarding Lead (DSL).

## **Monitoring and Review**

- The nursery leadership team monitors practice, resources, and outcomes to ensure fairness.
- This policy is reviewed annually or sooner if guidance or legislation changes.
- Children's and families' views are considered in shaping our approach to inclusion.
